ELDER LAW

Medicare Supplemental Policies Who, What, When and How (pt 2)

Medicare comes with a multitude of deductibles, copays and exclusions to coverage and actually only covers about half of the medical costs incurred by the user. A supplemental package can help to cover those items not covered by Medicare.

As discussed in the last article, there are about 8 standard packages sold by many different insurance companies with many different costs associated with the coverage. Company 1 may only charge \$75.00 per month for Plan G while Company 2 may charge \$300 for that same plan. While the plan itself covers the very same services.

Each of these frequently sold plans provide individuals a variety of benefits and the different benefits provided allow you to choose the correct plan. Here is a brief list of some of the services that each package must include:

Coinsurance for days 61 - 90 during a hospital stay;

2. Coinsurance for days 91 - 150 of a hospital stay (lifetime reserve days); and

All hospital-approved costs from day 151 through day 365. 3.

In addition to the core items covered by ALL packages, plans, A, B, C. D. F and G will all cover:

- 20 percent coinsurance for Part B medical charges; and
- 2. A certain amount of blood beyond what Medicare covers.

Other plans include total coverage for certain preventative procedures, coverage for days 21 to 100 in a skilled nursing facility (nursing home), prescription drug coverage as well as foreign travel emergencies.

It is important to evaluate your need for a supplemental policy during your enrollment period. During the enrollment period you cannot be denied a supplemental policy regardless of pre-existing conditions. It is also important to know that these policies do not cover all expenses that are not covered by Medicare, so your careful evaluation of your needs is important. Also, important to know is that nursing home care will not be covered by Medicare or a supplemental policy beyond the 100 day of coverage.

Remember that these policies typically do not cover prescription plans either. The prescription plan will be an additional supplemental plan you will need to evaluate for purchase.
