

The City of Paris City Commission, in accordance with KRS Chapter 132 and the requirement of the General Assembly to publish information contained herein, is providing notice that it will hold a public hearing on Friday, September 25, 2020 at 9:00 AM (EST) in the Commission Chambers of the Paris Municipal Building located at 525 High Street.

This hearing is to hear comments related to the establishment of tax rates, for general governmental activities, for Fiscal Year 2020-2021 and Calendar Year 2021. The Compensating Tax Rate would be \$0.1030 per \$100 valuation for Real Property and would result in an estimated \$591,000 in FY 20221.

Previous, and proposed tax rates, include:

For Fiscal Year 2020-2021:

Real Property  
FY 2019-2020 rate is \$0.1130 per \$100 valuation resulting in an estimated \$580,000  
Proposed FY 2020-2021 rate is \$0.1070 per \$100 valuation resulting in a projected revenue of \$600,000

Personal Property  
FY 2019-2020 rate is \$0.1179 per \$100 valuation resulting in an estimated \$103,000  
Proposed FY 2020-2021 rate is \$0.1411 per \$100 valuation resulting in a projected revenue of \$111,000

For Calendar Year 2021:  
Motor Vehicles & Watercraft  
Calendar Year 2020 rate is \$0.1700 per \$100 valuation resulting in an estimated \$106,000  
Proposed Calendar Year 2021 rate is \$0.1700 per \$100 valuation resulting in an estimated \$110,000

**SUMMARY OF PROCEDURES AND FINDINGS**

**AGREED-UPON PROCEDURES OF THE BOURBON COUNTY CLERK**

For The Period January 1, 2019 Through December 31, 2019


The Bourbon County Clerk applied for and received approval from the Auditor of Public Accounts (APA) to obtain an Agreed-Upon Procedures (AUP) engagement for calendar year 2019 in accordance with KRS 43.070(1)(c). AUP reports present the procedures performed and the results of those procedures, called findings. The summary below presents those findings for which an exception was identified during the AUP engagement.

During the AUP engagement of the Bourbon County Clerk, the following exceptions were noted:

- The county clerk's operating disbursements were compared to the county clerk's approved budget and the county clerk exceeded the budget for operating disbursements by \$7,804.
- The county clerk did not perform monthly bank reconciliations on all accounts. The December 31, 2019 bank reconciliations were not reconciled to the bank accurately.
- Excess fees due to fiscal court were recalculated. There are \$265 excess fees due to the fiscal court.

Findings related to procedures for which there were no exceptions identified, and official responses to exceptions are not included in the summary above, but can be found in the full report.
