

The awards program was created in 2005 and is a project of the Kentucky Chamber of Commerce, Kentucky Society for Human Resource Management Council and Best Companies Group.



Adolescents Are Engaging in Underage Drinking and Substance Use

Alcohol continues to be the most widely used substance among America's youth, with an estimated 7.4 million people younger than the age of 21 drinking alcohol in the past month. Marijuana is also prevalent among adolescents. An estimated 1.2 million adolescents aged 12 to 17 used marijuana for the first time in 2017, which translates to approximately 3,300 adoles cents each day. Additionally, more than one-third of adolescents are misusing prescription pain medications. Research indicates that 53 percent of people aged 12 to 17 obtained prescription pain relievers for the most recent nonmedical use from a friend or relative for free.

AN ORDINANCE ESTABLISHING MOTOR VEHICLE AND WATERCRAFT TAX RATES FOR 2021

WHEREAS, the City of Millersburg in order to provide for necessary services and funding for essential municipal operations within the City of Millersburg, and to cover the costs altendant

Be it ordained by the City of Millersburg:

(1) That the motor vehicle and watercraft tax rate for such
