Philippians 3:14 "I press toward the mark for the prize of the high calling of God in Christ Jesus."

As we enter into this new year, there is one common thing that many people partake in and that is what is called a New Year's Resolution. Human beings have a desire for better within them, and because of this we always want to see ourselves change wherever it's needed. This desire is inherent and is manifested in all areas of life, from technology to becoming better at our chosen profession. It is not inherently wrong, although it can easily become so. People often make gods of their passions, and thus turn into idolaters, but the desire itself isn't wrong, as it is given by

You see, these "betterments" give us something to strive for, it gives us something to aim for and attain. Without it we become bored, and in a way even purposeless. As human beings, there must be always something that we are striving

This is especially true of Christians, and in God's benevolence, He has given us something to strive toward, and that's summed up in the verse above. It was Paul's burning desire to do what God wanted him to do, since he saw himself not belonging to himself, but to God. He wanted to do what he was created to do and that was to live a life in service to God, no matter what form that came in. Dear Christian, we are called to the same exact thing.

The truth is that this has been a very strange year, and the way things have been going, it looks like we are entering another strange one. In the midst of all this, it is very easy to become discouraged to the point that we aren't pressing toward the mark, and we don't want to press toward the mark. But dear Christian, we must not lose heart. We have been created with the singular purpose of glorifying God, and must not let the discouragements of this life bring us down. We must keep on pressing.

Notice that Paul calls it the "prize of the high calling of God." Understand, this is not directly speaking to a reward for living as the Christians we ought to be (although there are rewards that will be given). But rather, Paul is saying that to be called of God IS the prize! Consider: to be a Christian is to be called of God, and we are called to something phenomenal. We are called to give the message of the gospel which can save people from eternal wrath, change lives, and turn the world upside down! What other calling is there that can do anything even remotely close to this? This the mark that we are to be pressing toward. And we must not give up.

As we enter into this new year, you may have your different resolutions. Some you may keep, some you may not. But may this one resolution be at the top: that you will press toward the mark. Not press toward it on good days, when you're feeling up to it, or if things go your way, but press toward it no matter what. If another world-wide virus breaks out, you'll keep on pressing. If the world once again goes to war, you'll keep on pressing. If you receive numerous blessings, if you journey through deep valleys; you'll keep on pressing. We have a glorious calling, and by God's grace, may we be resolute on this: Press toward the mark.
