Arena with the Tigers. He scored two points, grabbed five rebounds and dished an assist in the contest. He received a loud ovation from Big Blue Nation during player introductions.

Play of the Game: Playing with a bad left shoulder, Butler used his right shoulder to throw down a one-handed slam in transition to finish off the Wildcats 15-0 first half run.

MVP: Otega Owheh. On Senior Night, the junior Owheh stole the show as he scored 24 points, shot 9-for-11 from the field, grabbed eight rebounds, picked up three steals and dished

three assists to lead Kentucky to victory.

“I really thought double zero [Oweh] was phenomenal tonight,” LSU head coach Matt McMahon said post-game. “I thought he really set the tone for the game on both ends of the floor. His physicality defensively, but then he was so efficient on the offensive end tonight. I thought he really dominated the game from the wing position.”

night. It’s really hard to simulate their pace of play in transition. They were fantastic there, pushing the basketball, getting easy threes in the open floor.”
