Sumner said the hospital is already taking appointments for the dermatology clinic.

We're already started to try to go ahead and fill our schedule," he noted of the new clinic.

Sumner said Dr. Tanner Parrent of Hopkinsville is the collaborative partner with the clinic, which can be reached by phone at 270-350-4328.

The CEO also noted that the hospital continues to work to get its new magnetic resonance imaging machine in place.

Chief Financial Officer Don Michael reported to the board last week what he said was a very good month for the hospital financially in March.

Michael noted that there were 25 admissions for the month and 279 patient days, both of those statistics more than what they were at the same time last year, according to Michael.

He added that emergency room visits, ambulance runs, surgery, radiology and physician office visits were all up in March.

"Cash remains strong, and looking at the income statement, revenues for the month were \$7,061,920," the finance officer said, noting that was about \$2 million more than last year.

\$2,305,063, or \$140,000 more than last year.

He noted that the bottom line for the hospital for March is \$772,607, almost twice where the hospital was last year, according to Michael.

Michael also said the bottom line for the 11 months ending at the end of March is \$5,302,429, or \$350,000 more than where the hospital was at the same time last year.

In other business:

• The board accepted initial appointments for Dr. Maria Garcia in clinical pathology and Jamie Slagle, an advanced practice registered nurse in dermatology and reappointments for Laressa Bazzell, a nurse anesthetist in anesthesia and Dr. Todd Wical, a family medical doctor in emergency medicine.

• An ambulance that the hospital was to receive in May has now been pushed back to August or September, but Sumner said the hospital has a couple of new ambulances sitting in the county garage ready to g0.

• Sumner said a new emergency sign for the hospital has already been ordered; it will be lit up on both sides, he said, and it should be ready to put in place in another six weeks.

• The hospital's board of trustees took no action following an executive session.

#### **INSPECTION PERIOD** FOR THE PROPERTY TAX ASSESSMENT ROLL

The Trigg County real property tax roll will be opened for inspection from May 12, 2025, through May 27, 2025. Under the supervision of the Property Valuation Administrator or one of the deputies, any person may inspect the tax roll.

This is the January 1, 2025, assessment on which the city and county tax bills will be generated and mailed out by The Trigg County Sheriff around October 1, 2025. Tax bills are due without penalty and interest by December 31, 2025.

The tax roll is in the office of the Property Valuation Administrator in the Trigg County Courthouse Annex and may be inspected between the hours of 8:00 A.M. and 4:00 P.M.

Any taxpayer desiring to appeal an assessment on real property made by the P.V.A. must first request a conference with the P.V.A. or a deputy. The conference may be held prior to or during the inspection period. Written documentation supporting your opinion of value will continue to be required. This would include a recent appraisal, comparable sales, a copy of your insurance policy, or proof of damage, or a subsidiated being increasting the aurors and the D.V.A. scheduled home inspection between the owner and the P.V.A.

Any taxpayer still not satisfied with an assessment on real property, after the conference with the P.V.A. may appeal to the county board of assessment appeals.

The appeal must be filed with the county clerk's office no later than one work day following the conclusion of the inspection period. Please contact the County Clerk's office to receive instructions on the method the office is using to accept appeals this year and to obtain a form that can be used to file your appeal.

Any taxpayer failing to appeal to the county board of assessment appeals, or failing to appear before the board, either in person or by designated representative, will not be eligible to appeal directly to the Kentucky Board of Tax Appeals.

Appeals of personal property assessments shall not be made to the county board of assessment appeals. Personal property taxpayers shall be served notice under the provisions of KRS 132.450(4) and shall have the protest and appeal rights granted under the provisions of KRS 131.110.

The following steps should be taken when a taxpayer does not agree with the assessed value of personal property as determined by the property valuation administrator.

- 1. Taxpayer must list under protest (for certification) what they believe to be the fair cash value of their property
- 2. Taxpayer must file a written protest directly with the Department of Revenue, Office of Property Valuation within 30 days from the date of the notice of assessment. This protest must be in accordance with KRS 131.110.
- 4. The final decision of the Department of Revenue may be appealed to the Kentucky Board of Tax Appeals
