from electric vehicles.

part of a program to advance technologies and processes for recycling and reusing batteries

In total, DOE awarded \$73.9 million to 10 applicants. TTU's efforts are focused on bringing more electric vehicles and charging stations to rural areas. Concurrently, a goal of the Automotive Powertrain and Emissions Control Laboratory at TTU has been to make electric vehicles more accessible to people living in rural areas. One of the biggest obstacles to this is ensuring these vehicle owners have places to charge these electric vehicles. The solution has been mobile charging stations. The project does not involve Tri-County Electric except with electrical supply when the project is completed. The \$30,000 grant for Scottsville is slated for completion in the fall of 2025.
