ORDINANCE 2025-10

City of Harrodsburg Water Department Leak Check Policy

An Ordinance of the City of Harrodsburg, Kentucky that relates to the business policies of the Harrodsburg Water Department: WHEREAS, the Board of Commissioners of the City of Harrodsburg desires to set forth an Ordi-

nance setting forth how the Water Department shall handle leak checks. NOW, THEREFORE, be it enacted by the City of Harrodsburg, Kentucky the following Utility Billing Department policy relating to checking for water leaks.

If a customer receives their water bill and is concerned they have a leak, they should contact the Utility Billing Department and request a leak check;

• Leak checks will be scheduled during normal business hours (Monday through Friday from 8 • The customer must be present during leak checks to ensure that no water is being used inside

or outside the home while the check is being conducted. · The City will provide one complimentary leak check per calendar year. If additional leak

checks are requested, they shall be billed a \$50 service fee. • The service fee will be waived if the leak is found to be on the city side of the meter.

• If a leak is discovered on the customer side of the meter, the customer shall be responsible for contacting a plumber to locate the leak and make any necessary repairs. If the customer does not make repairs in a reasonable amount of time, the City reserves the right to turn the water off until such time as repairs are made.

Upon completion of repairs, the customer may request a leak adjustment on their water bill in accordance with Ordinance 2025-08.

WHEREFORE, this Ordinance was approved by the City Commissioners of Harrodsburg on the 9th day of June, 2025. This Ordinance shall become effective upon its passage, approval and publication as required by law.

ORDINANCE NUMBER 2025-06

AN ORDINANCE OF THE CITY OF HARRODSBURG, KENTUCKY AMENDING CODE OF ORDINANCES TITLE V: PUBLIC WORKS, CHAPTER 52, SEWER USE, SECTION 52.145 (C) 3, SEWER SERVICE RATES

WHEREAS, the Board of Commissioners of the City of Harrodsburg desires to amend the sewer use, Section 52.145 (c) 3, which were last comprehensively updated by Ordinance 2024-15 and; WHEREAS, the City of Harrodsburg is improving the Waste Water Treatment Plant, pump stations,

and wastewater lines; since updating their infrastructure several loans to Rural Development and Kentucky Infrastructure Authority are due to be repaid. Additional revenues are needed in order to meet the minimum qualifications on the letter on conditions to pay the debt service on the loans;

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF HARRODSBURG THAT THE FOLLOWING RATES BE ADOPTED;

(3) Minimum sewer rate: The minimum sewer bill shall be [\$17.44] \$17.95 per month, and each sewer customer shall be entitled to 250 cubic feet of sewer service consumption per month to customers of all size connections, except for any contractual arrangements with specific customers for additional surcharges.

ORDINANCE 2025-09

City of Harrodsburg Water Department Pool Adjustment Policy

An Ordinance of the City of Harrodsburg, Kentucky that relates to the business policies of the Har-

WHEREAS, the Board of Commissioners of the City of Harrodsburg desires to set forth an Ordinance setting forth how the Water Department shall handle adjustments to bills associated with the

NOW, THEREFORE, be it enacted by the City of Harrodsburg, Kentucky the following Utility Billing Department policy relating to adjustments to bills related to swimming pools.

- 1. The City of Harrodsburg Water Department, at its discretion, may provide a billing adjustment for sewer charges related to filling a swimming pool, provided that the water consumption is at least 4,000 gallons (535 cubic feet) over the customer's average usage OR is greater than three
- 2. All requests for pool adjustments must be made in writing within 30 days of the original due date of the high bill using the pool adjustment request form available online or in-person at the Water Department. Customers will be required to provide documentation, including pool dimensions, shape, estimated gallons, exact fill dates and photographic proof. Failure to do so will forfeit the customer's right to a pool adjustment.
- 3. The credit shall be determined based on the excess usage (difference between consumption on the high bill from filling the pool and the average usage from the previous 12 months). The credit will be limited to 50% of excess sewer usage consumption charges. If a customer does not have 12-months of history, the credit will be based on the history available. Service fees, sewer surcharge fees, and charges other than water/sewer consumption shall be excluded from the pool
- 4. In order to qualify for a pool adjustment, the customer account must be current (no past due balances) and must not have been subject to shut off within the previous 12-month period.
- 5. Approved pool adjustment credits will appear on a future billing (not necessarily the bill when charges were incurred). The customer shall be responsible for paying their bill in full while waiting for the pool adjustment.

WHEREFORE, this Ordinance was approved by the City Commissioners of Harrodsburg on the 9th day of June, 2025.
