

months to trust my opinion of him and our compatibility, and what's with all this freaking pressure, Kevin?

As the pressure mounts, it tends to displace those other priorities, until it's all about the pressure itself how to make it stop.

After drawing your line: "Please respect that. Pushing the conversation says you see my 'no' as negotiable. Not OK."

Take his response seriously, both in the moment and over time.

Can he accept this without getting defensive?

If yes, then can he live with your boundary, without chafing, just because that's the right thing to do?

This crossroads for a newish relationship is so telling. It is the crossroads. You're saying that you and your needs are right beside him and his needs, holding the same degree of importance. He either grasps this

immediately, sees how his cohabitation-pressure campaign walks all over your equal standing, apologizes and backs off to let you think — or he doubles down on his impatience and keeps treating you as an obstinate means to his ends.

# Lochte's 200 IM world mark falls to Frenchman

Leon Marchand sliced the pool water in 1 minute,52.61 seconds to break

Ryan Lochte's 200-meter individual medley world record at the World Aquatics Championships on Wednesday in Singapore.

The four-time Olympic

gold medalist broke the 14-year-old record in the semifinals of the event at the Singapore Sports Hub.

"I'm grateful for my coaches and all the staff behind me," Marchand, who earned a \$30,000 check for his efforts, said on a streaming broadcast of the event. "It's been a pretty hard season, but I'm so happy to be here."

**American Shaine Casas** finished second, 2.44 seconds behind the Frenchman. Great Britain's Duncan Scott placed

Lochte set the record with a 1:54.00 on July 28, 2011, at the world championships. He also owned the previous mark from a 1:54.10 swim in 2009. Michael Phelps set the record in the event eight times before it was broken by Lochte. He clocked a 1:54.23 for his fastest time at the 2008 Summer Olympics.

Marchand will compete in the finale at the 2025 World Aquatics Championships -- with a chance to break his own record --Thursday in Singapore.

# Olympic medalist Kerley pulls out of USATF Champs

Sprinter Fred Kerley will not take part in the USA Track and Field Championships, set to begin

Thursday in Eugene, Ore. His withdrawal from the event makes the two-time Olympic medalist unable to participate in the World Championships in Tokyo.

A specialist in the 100meter distance, Kerley, 30, announced his withdrawal on social media

Wednesday.

"The 100m should be a straight sprint. 2025 has presented many hurdles. Taking some time out to get back on track. No USATF Champs this year. Thanks to all my supporters," he posted.

Kerley won gold medals in the 100 at the 2022 World Championships in Eugene and in the 400 relay in Budapest in 2023.

At the Olympics, he took home a silver medal from the 2020 Tokyo

Games and a bronze from the 2024 Paris Games.

His personal best in the event is 9.76 seconds, set in 2022 in Eugene.

Kerley was arrested in Florida in May and charged with touch or strike battery after his former girlfriend alleged he struck her in the face with a closed fist.

At the time, his attorney told The Athletic that Kerley was arrested without a "thorough investigation."

"Fred never battered anyone," Richard L. Cooper said in a statement to The Athletic. "We are focused on working with prosecutors to show that this arrest was a mistake and no charges should be filed. I am confident in that goal."
