subsequent defensive team requests for that half-inning. Additionally, Rule 2-10-3 was added to define a player-toplayer defensive meeting as having two or more defensive players.

"A player-to-player defensive meeting is a natural and essential part of the game whether it's strategy, encouragement or clarification, but having multiple meetings in a half-inning adds additional time that lengthens a contest and is not in the best interest of the game," Hopkins said. "A charged conference, however, involves direct coaching intervention with either a coach or a non-playing representative and is intended to provide instruction. The distinction ensures we honor

both the flow of the game and the role of coaching."

Two rules changes were approved to bring the Baseball Rules Book in line with all NFHS rules. Language added to Rule 1-4-4 allows a school's name, nickname, logo, mascot and/or player's name to be permitted on a uniform top and/or pants beginning in 2027.

In addition, Rule 1-6-3 states that "no player shall wear any audio (microphone) or video (camera) device during the game."

Notice to Taylor County Taxpayers

Mark Carney,Taylor County Clerk, pursuant to KRS 424.330, announces that a list of the 2024 Delinquent Real Property Tax Bills (Certificates of Delinquency) will be published in the Central Kentucky News-Journal on Thursday, July 17, 2025. Any delinquent tax bills that have not been paid will be offered for sale on Wednesday, August 21, 2024 at 9:30 a.m. at the Taylor County Courthouse. The list of Certificates of Delinquency is also available for public inspection during the hours of 8 a.m.to 4:30 p.m. Monday through Friday at the County Clerk's office located in the courthouse at 203 North Court Street. This list may also be viewed on the Taylor County Clerk web site by going to www.tcclerk.com and clicking on the delinquent tax tab. The list will appear on the website beginning July 17, 2025. The tax sale will allow third party companies or other individuals the opportunity to purchase any delinquent tax bills that have not been paid by August 21. If you are a taxpayer who has a delinquent bill you should try your best to pay that bill before the August 20 sale date to avoid additional fees you will have to pay to anyone who may purchase your bill before they would elease the tax lien that they would have on your property. Anyone wishing to pay their delinquent tax bill before the sale date should come by the County Clerk's office to make payment. Any individual or company interested in purchasing more than three delinquent tax bills during the delinquent tax sale must register with the Department of Revenue in Frankfort and must also register with the County Clerk's office by the close of business on Monday, August 11, 2025. A Registration Form must be obtained from the clerk's office and filled out and turned back in along with a non-refundable Registration Fee. The registration fee is \$250.00 if the list that you turn in as possible bills to purchase is 25 delinquencies or more, or a \$10.00 registration fee per each delinquency that you turn in on your list that you wish to purchase if you plan to purchase less than 25 delinquencies. If you wish to purchase three certificates of delinquencies or ess then you do not have to register with the Department of Revenue, but you will need to register with the County Clerk's office. The registration fee for individuals wishing to purchase three bills or less will be \$10.00 for each bill you wish to purchase. If you are a company that has purchased prior year bills, then you will have the opportunity to purchase any 2024 delinquent bill that is for the same property as the delinquent bill you are already holding. If you wish to claim the 2024 delinquencies based on your holding a prior year claim a list of these bills will have to be turned in to the clerk's office by Monday, August 11. You can obtain a form to list the 2023 bills you may have a claim on from the clerk's office. If different companies have purchased two prior year bills on the same property, then the company with the most recent bill will have first priority. The sale of all other bills not having a prior year claim will be conducted in a manner similar to a professional sports draft in accordance with the provisions of House Bill 262 enacted by the 2009 General Assembly.
