Providence Council Fills Vacant Mayoral Seat

Providence City Council spent just 12 minutes in a closed session to to discuss candidates to fill the unexpired mayor's term that was vacated by the resignation of James "Butch" Hackney in late April and announced at the May 5, council meeting.

When the council convened Monday night, they approved minutes from a previous before going into a closed session per KRS 61.810(1)(f)—matters related to personnel at 6:01 p.m., but they had told the public on May 5, that would be the manner in which they handled discussing possible candidates to fill Hackney's expired term and fill the mayor's seat.

The council returned to open session at 6:13 p.m. with councilman Scott Frederick nominating Tom Glover to fill the vacancy. Frederick's motion received a second and the council voted unanimously for Glover. The local pharmacist was one of five individuals the council considered for the position. According to clerk Tiffany Conrad, initially six individual submitted letters of interest, but prior to the council meeting one of those withdrew a request to be considered.

Following the vote Conrad issued the oath of office to Glover who addressed a group of about 30 local residents who were present, noting "I just want to say Paula (his wife) and I thought a lot about this. She encouraged me and I've prayed about it. We have a wonderful town, and the people of Providence have been so kind." Glover stressed, "I have no agenda, but I come with a lot of vision. I appreciate the council's vote of support. We will lead this town together." The new mayor then took his seat at the table.

The council then moved on to other business including hearing concerns from three community members.

Marie Cline dressed the council to ask for the city's help in taking care of an issue with heavy trucks on Locust Street. She told the group that the trucks are making a turn on to Locust Street and running over the sidewalk damaging it. She also reported that she believes the trucks are overweight and too heavy to cross the bridge in that area as well as damaging sewer lines. Glover told Cline the city will look into the issue.

Steve Goolsby also addressed the council on several matters. The first regarded the fact that it is difficult for he and others to hear the business the council is discussing at their meetings. He asked that microphones and speakers be added.

Goolsby also asked that the city consider putting in a cross walk near his shop on Main Street. He noted that

since school is out children frequently cross the street and he fears someone will be hit by a vehicle. Goolsby also addressed citizens mowing their yards and blowing the grass clippings into the street, creating a danger for motorcyclists. Glover told Goolsby the city will work on those is-

Darrell Guinn also addressed the council regarding what he said was a "deal" he had with the previous mayor regarding upkeep on a ditch near his home in the Maple and Green streets area. According to Guinn, the city is supposed to maintain the ditch by mowing and picking up debris in the area, but that is not being done. He added that he pays extra every month to have his part of the ditch area mowed, but because other parts are not being maintained a snake and mosquito problem exists. In one area, the overgrowth is blocking the view of a stop sign, Guinn said. The mayor asked that Guinn give him time to see what the city can do to take

care of the problem.

Before the meeting adjourned, former Mike councilmember Syers told Glover, "You have my full support and I will do what I can to help."

The meeting adjourned at 6:35 with the next regular meeting set for June 2, at 6:00 p.m.

Pleas Entered In Webster County Circuit Court

travel on behalf of the United Soybean Board in support of committee or other industry-related meetings. Serving on the United Soybean Board is a commitment of time and talent to the entire U.S. soybean industry, representing

over 500,000 growers. Representation is based on production, and Kentucky currently has three USB directors. In years when there is a board seat coming available, the KSPB will submit to the U.S. Department of Agriculture the names of two potential nominees. The Secretary of Agriculture will make the final appointment. The chosen individual will begin serving a three-year term in December and will be eligible to serve up to two additional terms.
