Hawai'i Pacific University has officially named Brent Gibson as the new head coach of the HPU Women's Basketball program. The university made the announcement last week. After serving as the Interim Associate Head Coach, Gibson now becomes the seventh head coach in program history, bringing a well-rounded background in coaching, education, and leadership to the role.

Gibson, a Webster County native, is the son of Janice McClain and the late Phil Gibson, a long-time coach of the WCHS Lady Tro-

Gibson stepped into the interim position at Hawai'I Pacific University last season with a steady hand and a clear vision, quickly earning the trust of student-athletes and staff alike. His promotion reflects not only his basketball acumen but also his commitment to building a program grounded in discipline, academic success, and personal growth, a press release from the

district to have a generator at the plant for cases such as the one the district just experienced. He told the board he will continue to look for grants to help offset the cost of a generator that can run the plant in case of a power outage.

The superintendent also addressed the need for a line replacement in the Mt. Gilead/Mt. Pleasant area. He told the board that since 2023, the district has had 13 boil water advisories in that area due to leaks, the most recent of which was in an eight-inch main with two leaks. Baldwin provided data related to the cost of the repairs and advised that about 2000 feet of line replacement needs to be made. The water super intendent said that the district will save money by replacing the line, and showed the district the cost of line repairs over the last two years.

Baldwin provided quotes for replacing the line with the lowest quote coming from M and G Services in Marion at a cost off \$20,200. The district will purchase the materials for the line replacement. The cost for materials is about \$29,989, Baldwin said. Initially, the district received four quotes for the labor on the project and three quotes for the labor with Baldwin recommending the lowest quote for each. Work on the line replacement will start in July and will take about two weeks, Baldwin said. He added that some work will be done at night to keep from inconveniencing customers with water being cutoff. The board approved Baldwin's recommendations for both materials and labor and approved the project.

For many months the water district has awaited a response from the Public Service Commission regarding a rate change for water customers. Although the district had anticipated having a response on June 5, Baldwin reported that on June 4, the PSC notified the water district that the deadline for the notification has been extended to July 30, to allow the agency time to gather additional information.

The water superintendent also addressed the district's policy on the rate charged to repair leaks; line damage caused by customers. Since 2015, the hourly rate has been \$60 and has included both equipment use and labor; however. Baldwin noted that the rising costs of fuel, equipment repairs and man hours make it necessary to change the rate. He recommended the district charge an hourly rate for equipment use plus labor charges. The board approved the request.

In May, the district produced 29,032,660 gallons of water and sold 24,848,480 gallons.

# Clay City Council Approves Fiscal Year 2025-2026 Budget

Clay City Council met in regular session Tuesday evening with council members approving second reading of the fiscal year 2026 budget.

The council unanimously approved a \$1,934,763 budget for the coming fiscal year. That budget includes funding for employee raises, fire department needs, lights at the ball fields and money set aside for large equipment needs; the city's water tank is also expected to undergo an inspection this year. The city anticipates general fund revenue for \$791,793 \$917,575 in the utility fud and \$78,520 in the fire department fund. Other funding includes the street fund at \$32,325 and anticipated tourism revenue of about \$106,075.

The city's funding sources include property taxes, grants, golf cart permits and other funding sources with water, sewer and gas sales making up the bulk of the utility ac-

In addition to approving minutes

the previous meeting, the clerk's report and accounts payable, the council also heard a report from attorney Rebecca Johnson concerning a recent master commissioner's sale and learned that a delinquent tax payment from a resident has been made.

With no other business to come before the council the meeting

adjourned at 6:13 p.m. The next meeting of the Clay City Council is July 8, at 6:00 p.m.
