

#### 2025 PROPOSED TAX RATE PUBLIC HEARING

The Clark County Fiscal Court will hold a public hearing on Wednesday, August 13, 2025 at 8:30 A.M. at the Clark County Courthouse for the purpose of obtaining comments from the public regarding the proposed tax rate.

The tax rate levied last year was 8.0 and produced revenues in the amount of \$2,467,802. This year's compensating rate is 7.8 and will produce revenues in the amount of \$2,570,358. The Clark County Fiscal Court proposes a tax rate of 8.0 which will produce a total of \$2,616,858 in revenues.

Revenue expected from New Property is \$19,407; revenue expected from Personal Property is \$632,753; revenue

expected from Motor Vehicle is \$429,745; and revenue from Watercraft is \$0.00.

Revenue received in excess of last year's revenue will be used for payment of General fund expenditures.

The Kentucky General Assembly requires that the Clark County Fiscal Court publish this notice with the above information contained herein.
